AT&T Unit, Korean Consortium Pact on System 3600

AT&T Global information Solutions, a unit of AT&T Corp., reached an agreement to transfer computer equipment, technology and service products to a South Korean consortium that may be worth \$1 billion over the next five years.

AT&T Global Information said, the five-year deal could be worth \$50 million in its first year.

The South Korean consortium includes Samsung Electronics Co., Hyundai Electronics Industries Co. and the Research Institute of Advanced Computer Technology at Seoul National University. representing the Ministry of Trade, Industry and Energy.

AT&T will immafer technology, manufacturing and marketing information relating to its System 3600 massively parallel processing systems, known as MPP systems. The Korean Consortium will manufacture the systems locally after one year under a royalty agreement with AT&T. The agreement also covers support of key third party vendors.

The System 3600 is a computer capable of sifting through large databases by spiting the work among hundreds of microprocessors, all working on a parallel basis.

Under the deal, AT&T will also license products and services related to the system. These include software allowing thousands of information requests to be handled by a company and messaging system that includes electronic mail, data exchange, voice messages and other services.

The consortium has exclusive rights to the Korean market and will export products to potential 31 countries, including Russia, China, Taiwan, Hong Kong, Singapore, Malaysia and Thailand.*

IBM Announces New HD

Hard-Disk drive is showing more longevity than seemed possible in the 1980s. IBM, which set a record in 1989 by cramming 1 billion bits of data onto one square inch of disk surface, announced that it had boosted its world record to 3 billion bits- or 3 gigabits. That's nearly five times the density of the most advanced commercial disk drive: IBM's Travelstar LP 2.5 inch drive for subnote-book computers. IBM Engineers improved the cobalt-alloy recording surface by laying it down in a way that produces fine magnetic grains that still behave independently. They also shamk the heads that read and write to handle smaller bits. The head that reads works on the principle that electrical resistance fluctuates in varying magnetic fields. IBM is the only company massproducing these so-called magnetoresistive heads.*
